## D. Terms and conditions for participation in EDITC seminars

Written confirmation for the implementation of the training program will be sent within 3-5 days before the start date of the seminar. - Cancellations should be done in writing at least 5 working days prior to the start date of the seminar. Cancellations that do not meet this term are invoiced the entire cost of the seminar (including the subsidy). It is acceptable to replace a participant, provided that the substitute fulfills the seminar's participation criteria.
- 3. All registrations are strictly prepaid except for credit customers.
- 4. The company has the right to cancel or postpone a training program up to one day before the start date of the program. Any prepayments will be refunded.
